To address the disparate impact of climate change on women and support the efforts of women globally to address climate change, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE; TABLE OF CONTENTS.**

4 (a) SHORT TITLE.—This Act may be cited as the
5 “Women and Climate Change Act of 2018”.

1 **SEC. 2. FINDINGS.**

2 Congress finds the following:

3 (1) Women in the United States and around
4 the world are the linchpin of families and commu-
5 nities and are often the first to feel the immediate
6 and adverse effects of social, environmental, and eco-
7 nomic stresses on their families and communities.

8 (2) The United Nations has recognized, as one
9 of the central organizing principles for its work, that
10 “no enduring solution to society’s most threatening
11 social, economic and political problems can be found
12 without the full participation, and the full empower-
13 ment, of the world’s women”.

14 (3) The United Nations Development Pro-
15 gramme 2013 Human Development Report has
16 found that the number of people living in extreme
17 poverty could increase by up to 3,000,000,000 by
18 2050 unless environmental disasters are averted by
19 coordinated global action.

1 (4) Climate change is already forcing vulnerable
2 communities in developing countries to face unprece-
3 dented climate stress, including water scarcity and
4 drought, as well as severe weather events and floods,
5 which can lead to reduced agricultural productivity,
6 food insecurity, and increased disease.

7 (5) Climate change exacerbates issues of scar-
8 city and lack of accessibility to primary natural re-
9 sources, forest resources, and arable land for food
10 production, thereby contributing to increased conflict
11 and instability, as well as the workload and stresses
12 on women farmers, who are estimated to produce 60
13 to 80 percent of the food in most developing coun-
14 tries.

15 (6) Women will disproportionately face harmful
16 impacts from climate change, particularly in poor
17 and developing nations where women regularly as-
18 sume increased responsibility for growing the fam-
19 ily's food and collecting water, fuel, and other re-
20 sources.

21 (7) Epidemics, such as malaria and zika, are
22 expected to worsen and spread due to variations in
23 climate, putting women (especially pregnant mothers
24 and women who hope to become pregnant) and chil-

1 dren without access to prevention and medical serv-
2 ices at risk.

3 (8) The direct and indirect effects of climate
4 change have a disproportionate impact on
5 marginalized women such as refugee and displaced
6 persons, religious or ethnic minorities, adolescent
7 girls, and women and girls with disabilities and
8 those who are living with HIV.

9 (9) Conflict has a disproportionate impact on
10 the most vulnerable populations including women,
11 and is fueled in the world's poorest regions by
12 harsher climate, leading to migration, refugee crises,
13 and conflicts over scarce natural resources including
14 land and water.

15 (10) Displaced, refugee, and stateless women
16 and girls face extreme violence and threats, includ-
17 ing—

18 (A) being forced to exchange sex for food
19 and humanitarian supplies;

20 (B) being at increased risk of rape, sexual
21 exploitation and abuse; and

22 (C) being at increased risk for HIV, STIs,
23 unplanned pregnancy, and poor reproductive
24 health.

1 (11) It is predicted that climate change will
2 lead to increasing frequency and intensity of extreme
3 weather conditions, precipitating the occurrence of
4 natural disasters around the globe.

5 (12) The relocation and death of women, and
6 especially mothers, as a result of climate-related dis-
7 asters often has devastating impacts on social sup-
8 port networks, family ties, and the coping capacity
9 of families and communities.

10 (13) The ability of women to adapt to climate
11 change is constrained by a lack of economic free-
12 doms, property and inheritance rights, as well as ac-
13 cess to financial resources, education, family plan-
14 ning and reproductive health, and new tools, equip-
15 ment, and technology.

16 (14) Despite a unique capacity and knowledge
17 to promote and provide for adaptation to climate
18 change, women often have insufficient resources to
19 undertake such adaptation.

20 (15) Women are shown to have a multiplier ef-
21 fect by using their income and resources, when given
22 the necessary tools, to increase the well-being of
23 their children and families, and thus play a critical
24 role in reducing food insecurity, poverty, and socio-
25 economic effects of climate change.

1 (16) Women are often underrepresented in the
2 development and formulation of policy regarding
3 mitigation and adaptation to climate change, even
4 though they are often in the best position to provide
5 and consult on adaptive strategies.

6 **SEC. 3. DEFINITIONS.**

7 In this Act:

8 (1) **APPROPRIATE CONGRESSIONAL COMMIT-**
9 **TEES.**—The term “appropriate congressional com-
10 mittees” means—

11 (A) the Committee on Foreign Affairs and
12 the Committee on Appropriations of the House
13 of Representatives; and

14 (B) the Committee on Foreign Relations
15 and the Committee on Appropriations of the
16 Senate.

17 (2) **CLIMATE CHANGE.**—The term “climate
18 change” means a change of climate that is attrib-
19 uted directly or indirectly to human activity and al-
20 tering the composition of the global atmosphere.

21 (3) **DEVELOPING COUNTRY.**—The term “devel-
22 oping country” means those countries classified by
23 the World Bank as having a low-income or lower-
24 middle-income economy.

1 (4) DISPARATE IMPACT.—The term “disparate
2 impact” refers to the historic and ongoing impacts
3 of the pattern and practice of discrimination in em-
4 ployment, education, housing, banking, health, and
5 nearly every other aspect of life in the economy, so-
6 ciety, or culture that have an adverse impact on mi-
7 norities, women, or other protected groups, regard-
8 less of whether such practices were motivated by dis-
9 criminatory intent.

10 (5) ENVIRONMENTAL DISASTERS.—The term
11 “environmental disasters” means specific events
12 caused by human activity that result in seriously
13 negative effects on the environment.

14 (6) ENVIRONMENTAL REFUGEES.—The term
15 “environmental refugees” means people displaced be-
16 cause of environmental causes, notably land loss and
17 degradation, and natural disasters, who have left
18 their community or country of origin.

19 (7) EXTREME POVERTY.—The term “extreme
20 poverty” means having an income level or living
21 standard at a level of extreme deprivation based on
22 living with income below 50 percent of the poverty
23 line as established by the individual country at issue,
24 or below \$1.90 per day as determined by the World
25 Bank.

1 (8) **EXTREME WEATHER.**—The term “extreme
2 weather” means unexpected, unusual, unpredictable,
3 severe, or unseasonal weather that is at the extremes
4 of the historical distribution range that has been
5 seen in the past.

6 (9) **FEDERAL AGENCY.**—The term “Federal
7 agency” means any executive department, Govern-
8 ment corporation, Government-controlled corpora-
9 tion, or other establishment in the executive branch
10 of the Government (including the Executive Office of
11 the President), or any independent regulatory agen-
12 cy.

13 (10) **FOOD INSECURITY.**—The term “food inse-
14 curity” means a lack of consistent access to food.

15 (11) **MOST VULNERABLE COMMUNITIES AND**
16 **POPULATIONS.**—The term “most vulnerable commu-
17 nities and populations” means communities and pop-
18 ulations, including women, impoverished commu-
19 nities, children, people with disabilities, and indige-
20 nous peoples, who are at risk of substantial adverse
21 impacts of climate change and have limited capacity
22 to respond to such impacts.

23 (12) **POVERTY.**—The term “poverty” means an
24 income level and living standard insufficient to meet
25 basic needs.

1 **SEC. 4. STATEMENT OF POLICY.**

2 It is the policy of the United States, in partnership
3 with affected countries, donor country governments, inter-
4 national financial institutions, international nongovern-
5 mental organizations, and civil society groups, especially
6 those led by women, to combat the leading causes of cli-
7 mate change, mitigate the effects of climate change on
8 women and girls, and elevate the participation of women
9 in policy, program, and community decision-making proc-
10 esses with respect to climate change, by—

11 (1) establishing the Federal Interagency Work-
12 ing Group on Women and Climate Change, mission
13 of which is to prevent and respond to the effects of
14 climate change on women globally; and

15 (2) implementing a coordinated, integrated, evi-
16 dence-based, and comprehensive strategy on Women
17 and Climate Change throughout United States poli-
18 cies in the future.

19 **TITLE I—STRATEGIES, POLICIES,**
20 **AND PROGRAMS**

21 **SEC. 101. FEDERAL INTERAGENCY WORKING GROUP ON**
22 **WOMEN AND CLIMATE CHANGE.**

23 (a) **ESTABLISHMENT.**—There is established in the
24 Department of State a Federal Interagency Working
25 Group on Women and Climate Change, which shall be
26 chaired by the Senior Coordinator for Women and Climate

1 Change designated pursuant to section 201. Members of
2 the Working Group shall be selected by their respective
3 agency heads from the senior ranks of such agencies. The
4 Working Group shall—

5 (1) be composed of a senior representative from
6 each of—

7 (A) the Department of State, including—

8 (i) the Office of Global Women's
9 Issues;

10 (ii) the Office of Civil Rights;

11 (iii) the Bureau of Oceans and Inter-
12 national Environmental and Scientific Af-
13 fairs;

14 (iv) the Bureau of Population, Refu-
15 gees, and Migration;

16 (v) the Bureau of Democracy, Human
17 Rights, and Labor; and

18 (vi) the Bureau of International Orga-
19 nization Affairs;

20 (B) the Agency for International Develop-
21 ment;

22 (C) the Centers for Disease Control and
23 Prevention;

24 (D) the Environmental Protection Agency;

1 (E) the National Oceanic and Atmospheric
2 Administration;

3 (F) the National Institutes of Health;

4 (G) the National Science Foundation;

5 (H) the White House Council on Environ-
6 mental Quality; and

7 (I) other members as designated by the
8 Senior Coordinator;

9 (2) coordinate and integrate the development of
10 all policies and activities of the Federal Government
11 across all agencies relating to—

12 (A) combating the effects of climate
13 change on women in the international sphere;
14 and

15 (B) increasing the Federal Government re-
16 sponse and strategy to fight climate change for
17 the security of the United States and the inter-
18 national community;

19 (3) allow each member of the Working Group
20 to act as a representative for the Working Group
21 within the Federal department or agency of such
22 member to facilitate implementation of the Working
23 Group policies within such department or agency;

24 (4) ensure that all relevant Federal depart-
25 ments or agencies comply with appropriate guide-

1 lines, policies, and directives from the Working
2 Group, the Department of State, and other Federal
3 departments or agencies with responsibilities relating
4 to climate change;

5 (5) ensure that Federal departments or agen-
6 cies, State governments, and relevant congressional
7 committees, in consultation with non-governmental
8 organizations and policy experts in the field and
9 State and local government officials who administer
10 or direct policy for programs relating to climate
11 change and women—

12 (A) have access to, receive, and appro-
13 priately disseminate best practices in the ad-
14 ministration of programs;

15 (B) have adequate resources to maximize
16 the public awareness of such programs;

17 (C) increase the reach of such programs;

18 (D) share relevant data; and

19 (E) issue relevant guidance; and

20 (6) identify and disseminate best practices for
21 improved data collection on the part of each agency
22 and department relevant to the disparate impact of
23 climate change on women, including in—

24 (A) unpaid care work;

1 (B) community advocacy, activism, and
2 representation;

3 (C) women and girls' access to education;

4 (D) access to comprehensive health care,
5 include reproductive health and rights;

6 (E) desertification and food insecurity;

7 (F) community infrastructure, multi-level
8 Government adaptability, and climate-resilience;

9 (G) climate and weather-related crisis re-
10 sponse including safety from gender-based vio-
11 lence; and

12 (H) women's involvement and leadership in
13 the development of frameworks and policies for
14 climate resilience.

15 (b) CONSULTATION PERMITTED.—The Federal
16 Interagency Working Group may consult and obtain rec-
17 ommendations from such independent non-governmental
18 policy experts, State and local government officials, inde-
19 pendent groups and organizations, or other groups or or-
20 ganizations as the Senior Coordinator determines will as-
21 sist in carrying out the mission of the Office.

22 (c) FREQUENCY OF MEETING.—The Federal Inter-
23 agency Working Group shall meet on a quarterly basis to
24 discuss and develop policies, projects, and programs, and
25 shall meet with the Senior Coordinator for Women and

1 Climate Change on a monthly basis to report on and dis-
2 cuss implementation of such policies, projects, and pro-
3 grams.

4 **SEC. 102. DEVELOPMENT AND IMPLEMENTATION OF**
5 **STRATEGY AND POLICIES TO PREVENT AND**
6 **RESPOND TO THE EFFECTS OF CLIMATE**
7 **CHANGE ON WOMEN GLOBALLY.**

8 (a) INITIAL STRATEGY.—Not later than 180 days
9 after the date of the enactment of this Act, the Senior
10 Coordinator for Women and Climate Change and the Am-
11 bassador-at-Large for the Office of Global Women’s Issues
12 of the Department of State, in consultation with the Fed-
13 eral Interagency Working Group, shall develop and submit
14 to the appropriate congressional committees a United
15 States National and International Strategy to prevent and
16 respond to the effects of climate change on women. The
17 strategy shall include—

18 (1) recognizing the disparate impacts of climate
19 change on women and the efforts of women globally
20 to address climate change;

21 (2) taking effective action to prevent and re-
22 spond to climate change and mitigate the effects of
23 climate change on women around the world, as well
24 as to promoting gender equality, economic growth,
25 public health, racial justice, and human rights;

1 (3) implementing the United Nations Sustain-
2 able Development goals listed in subsection (e),
3 through and beyond 2030, as part of the strategy to
4 prevent and respond to the effects of climate change
5 on women globally;

6 (4) implementing balanced participation of men
7 and women, especially individuals from the commu-
8 nities most impacted, in climate change adaptation
9 and mitigation efforts, including in governance and
10 diplomatic positions within the United States Gov-
11 ernment;

12 (5) working at the local, national, and inter-
13 national levels, including with individuals, families,
14 and communities, to prevent and respond to the ef-
15 fects of climate change on women;

16 (6) systematically integrating and coordinating
17 efforts to prevent and respond to the effects of cli-
18 mate change on women internationally into United
19 States foreign policy and foreign assistance pro-
20 grams;

21 (7) investing in research on climate change
22 through appropriate Federal departments or agen-
23 cies and funding of university and independent re-
24 search groups on the various causes and effects of
25 climate change;

1 (8) developing and implementing gender-sen-
2 sitive frameworks in policies to address climate
3 change, which account for the specific impacts of cli-
4 mate change on women;

5 (9) developing policies to support women who
6 are particularly vulnerable to climate change impacts
7 to prepare for, build their resilience, and adapt to
8 such impacts, including a commitment to increase
9 education and training opportunities for women to
10 develop local resilience plans to address the effects
11 of climate change;

12 (10) developing and investing in programs for
13 the education and empowerment of women and girls
14 in the United States and across the global commu-
15 nity, including to gather information on how climate
16 change is affecting their lives and for guidance on
17 the needs of their families and communities in the
18 face of climate change, in coordination with the dip-
19 lomatic missions of other countries;

20 (11) consulting with representatives of civil so-
21 ciety, including non-governmental organizations,
22 faith-based organizations, multilateral organizations,
23 local and international civil society groups, and local
24 climate change organizations and their beneficiaries

1 with demonstrated experience in preventing and re-
2 sponding to the effects of climate change on women;

3 (12) supporting and building local capacity in
4 developing countries, including with respect to gov-
5 ernments at all levels and non-governmental organi-
6 zations (especially women-led), to prevent and re-
7 spond to the effects of climate change on women;

8 (13) developing programs to empower women in
9 communities to have a voice in the planning, design,
10 implementation, and evaluation of strategies to ad-
11 dress climate change so that their roles and re-
12 sources are taken into account;

13 (14) including women in economic development
14 planning, policies, and practices that directly im-
15 prove conditions that result from climate change;

16 (15) integrating a gender approach in all poli-
17 cies and programs in the United States that are
18 globally related to climate change; and

19 (16) ensuring that such policies and programs
20 support women globally to prepare for, build resil-
21 ience for, and adapt to climate change.

22 (b) UPDATES.—The Senior Coordinator for Women
23 and Climate Change shall consult with the Federal Inter-
24 agency Working Group to collect information and feed-
25 back, to update the strategy and programs to prevent and

1 respond to the effects of climate change on women glob-
2 ally.

3 (c) IMPLEMENTATION PLAN.—Not later than 60
4 days after the date of the submission of the strategy under
5 subsection (a), the Senior Coordinator for Women and Cli-
6 mate Change shall submit to the appropriate congressional
7 committees an implementation plan and budget for the
8 strategy.

9 (d) ASSISTANCE AND CONSULTATION.—The Senior
10 Coordinator for Women and Climate Change shall assist
11 and provide consultation to the Secretary of State in pre-
12 venting and responding to the effects of climate change
13 on women globally.

14 (e) UNITED NATIONS SUSTAINABLE DEVELOPMENT
15 GOALS THROUGH AND BEYOND 2030.—The United Na-
16 tions Sustainable Development goals listed in this sub-
17 section are the following:

18 (1) Ending poverty in all its forms everywhere.

19 (2) Ending hunger, achieving food security and
20 improved nutrition, and promoting sustainable agri-
21 culture.

22 (3) Ensuring healthy lives and promote well-
23 being for all and at all ages.

1 (4) Ensuring inclusive, equitable, and quality
2 education and promoting lifelong learning opportuni-
3 ties for all.

4 (5) Achieving gender equality and empowering
5 all women and girls.

6 (6) Ensuring the availability and sustainable
7 management of water and sanitation for all.

8 (7) Ensuring access to affordable, reliable, sus-
9 tainable and modern energy for all.

10 (8) Promoting sustained, inclusive, and sustain-
11 able economic growth, full and productive employ-
12 ment, and decent work for all.

13 (9) Building resilient infrastructure, promoting
14 inclusive and sustainable industrialization, and fos-
15 tering innovation.

16 (10) Reducing inequality within and among
17 countries.

18 (11) Making cities and human settlements in-
19 clusive, safe, resilient, and sustainable.

20 (12) Ensuring sustainable consumption and
21 production patterns.

22 (13) Taking urgent action to combat climate
23 change and its impacts.

1 (14) Conserving and sustainably using the
2 oceans, seas, and marine resources for sustainable
3 development.

4 (15) Protecting, restoring, and promoting sus-
5 tainable use of terrestrial ecosystems, sustainably
6 managing forests, combating desertification, and
7 halting and reversing land degradation and biodiver-
8 sity loss.

9 (16) Promoting peaceful and inclusive societies
10 for sustainable development, providing access to jus-
11 tice for all, and building effective, accountable and
12 inclusive institutions at all levels.

13 (17) Strengthening the means of policy imple-
14 mentation and revitalize the global partnership for
15 sustainable development.

16 **TITLE II—OVERSIGHT AND** 17 **ACCOUNTABILITY**

18 **SEC. 201. SENIOR COORDINATOR FOR WOMEN AND CLI-** 19 **MATE CHANGE.**

20 (a) ESTABLISHMENT.—The Ambassador-at-Large of
21 the Office of Global Women’s Issues shall designate a cur-
22 rent employee serving as a Senior Advisor, or equivalent
23 role, to serve concurrently as the Senior Coordinator for
24 Women and Climate Change.

25 (b) IN GENERAL.—The Senior Coordinator shall—

1 (1) direct the activities, policies, programs, and
2 funding of the Department of State relating to the
3 effects of climate change on women, including with
4 respect to efforts to prevent and respond to these ef-
5 fects;

6 (2) advise the Secretary, the relevant heads of
7 other Federal departments and independent agen-
8 cies, and other entities within the Executive Office
9 of the President, regarding the establishment of—

10 (A) policies, goals, objectives, and priorities
11 for addressing and combating the effects of cli-
12 mate change on women; and

13 (B) mechanisms to improve the effective-
14 ness, coordination, impact, and outcomes of
15 programs relating to addressing and combating
16 the effects of climate change on women, in co-
17 ordination with experts in the field, non-govern-
18 mental organizations, and foreign governments;
19 and

20 (3) identify and assist in the resolution of any
21 disputes that arise between Federal agencies relating
22 to policies and programs to address and combat the
23 effects of climate change on women or other matters
24 within the responsibility of the Office.

1 (c) OVERSIGHT.—The Senior Coordinator for Women
2 and Climate Change shall report to the Ambassador-at-
3 Large for the Office of Global Women’s Issues and the
4 Secretary of State.

5 **SEC. 202. BRIEFING AND REPORT.**

6 Not later than 180 days after the date of the enact-
7 ment of this Act, and annually thereafter, the Amba-
8 sador-at-Large and Senior Coordinator for Women and
9 Climate Change shall—

10 (1) brief the appropriate congressional commit-
11 tees on—

12 (A) the effects of climate change on
13 women; and

14 (B) the prevention and response strategies,
15 programming, and associated outcomes with re-
16 spect to climate change; and

17 (2) submit to the appropriate congressional
18 committees an assessment of human and financial
19 resources necessary to fulfill the purposes of and
20 carry out this Act.
